

March Movie Madness Official Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN

Purchase does not increase chance of winning.

The word "contest" and "sweepstakes" are used interchangeably for the purposes of this document.

The prize: Two (2) Movie Tickets per winner per contest. No cash or other prize substitution permitted except at Sponsor's discretion. The prize is nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner.

How to enter: You will be entered by liking or commenting on the original post.

Terms and Conditions: By submitting an entry, you fully and unconditionally agree to and accept these Official Rules. Sweepstakes entries are limited to the United States and Alabama and is void where prohibited. Excludes Mutual Savings employees and their family members, Board of Directors and their family members and Supervisory Committee and their family members. All federal, state and local laws and regulations apply. Subject to any governmental approval that may be required, Sponsor reserves the right to, without prior notice and at any time, terminate the contest, in whole or in part, or modify the contest in any way, should any factor interfere with its proper conduct as contemplated by these Official Rules. Contest will begin on February 28, 2018 and will end on March 30th, 2018. Sponsor reserves the right in its sole discretion, to cancel the contest in its entirety.

Eligibility. Must be at least 18 years old to enter. Employees, officers, or directors of Sponsor, its affiliates, subsidiaries, and their children, parents, spouse, and members of their household are ineligible to participate. No purchase is necessary. Contest is open only to legal residents of the United States. A purchase does not enhance your chance of winning.

Effective date of entries. Automatic entries made will be effective on the day the post is liked or commented on and is valid for the respective week only.

Selection of winners. Winners will be determined by random drawing from all eligible entries received. Drawings will be held every Friday for the month of March. Winners must agree to the use of their names, voices, photos and/or likeness for the purpose of advertising, social media posting, trade, or promotion without further compensation, unless prohibited by law.

Notification of winners. Winner will be notified by Facebook. All decisions are final and binding. Should the email be returned or phone number is invalid, two more attempts will be made via email and one by regular mail if applicable. Winners must contact the Sponsor within 5 calendar days from the date the notification is sent by Sponsor to claim their prize. Failure to contact Sponsor within that 5 day period will result in immediate disqualification of the selected entrant and a new winner will be selected. No exceptions will be made to this rule. Sponsor is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winners. Other conditions. Sponsor, its agents and representatives, its affiliates, subsidiaries, advertising, promotion and fulfillment agencies and legal advisors are not responsible for and will not be liable for (I) late, lost, damaged, misdirected, incomplete, unintelligible or postage due entries; (II) telephone, electronic, hardware or software program, network, Internet or computer malfunctions, failures or difficulties of any kind; (III) failed, incomplete, garbled or delayed computer transmissions; (IV) any condition caused by events beyond the

control of Sponsor that may cause Contest to be disrupted or corrupted; (V) any injuries losses or damages of any kind arising in connection with or as a result of the Sweepstakes, or from participation in the Sweepstakes; or (VI) any printing or typographical error in any material associated with the Sweepstakes.

Indemnification.
